

Changfeng Establishes New Subsidiary in Jiangxi Province, China

TORONTO, ONTARIO--(May 26, 2010) - Changfeng Energy Inc. ("Changfeng", TSX VENTURE: CFY), a China based natural gas distributor, is pleased to announce that the Company and the Company's subsidiary, Hunan CNPC New Energy Investment Co., Ltd. established a wholly owned subsidiary of Ping Xiang Changfeng Gas Co., Ltd., which will be mainly engaged in the construction and distribution of pipeline natural gas in XiangDong District, PingXiang, City, Jiangxi Province, China.

Xiangdong District is one of the three administrative districts in Pingxiang City, Jiangxi province. Adjacent to Changsha, Zhuzhou and Xiangtan Economic Zone with developed transportation system, Xiangdong District is one of four ceramic manufacturing centers and the biggest industrial ceramic production base in China. Its annual production accounts for 70% of the national production in China.

The Xiangdong District Government initially consented to grant a 50-year concession right to Changfeng to operate the natural gas construction and distribution business (including LNG, LPG, pipeline gas, and gas refueling stations) in the existing administrative region and Pingxiang Industrial Ceramic Park in Xiangdong Districth.

"The establishment of the new subsidiary is a milestone for the Company to push forward our business growth in Mainland China. With the completion of the second west-to-east pipeline, the company continues to seek business opportunities on the selected cities along with extension of the stated own pipeline." Stated Mr. Huajun Lin, CEO and the Chairman of Changfeng Energy Inc. "By leveraging the relationship with CNPC, gas source is secured for our upcoming operation in Xiangdong Distict once the second west-to-east pipeline to be connected to Jiangxi Province and put into operation in first half of 2011."

Changfeng is engaged in the design and construction of natural gas distribution networks and distribution of natural gas to commercial and residential customers in the greater Sanya City region of Hainan Province, China. During the first quarter of 2010, the Company has completed trial operations of its first CNG filling station in Changsha, Hunan Province. The Company is headquartered in Toronto, Ontario and its shares trade on the TSX Venture Exchange.
